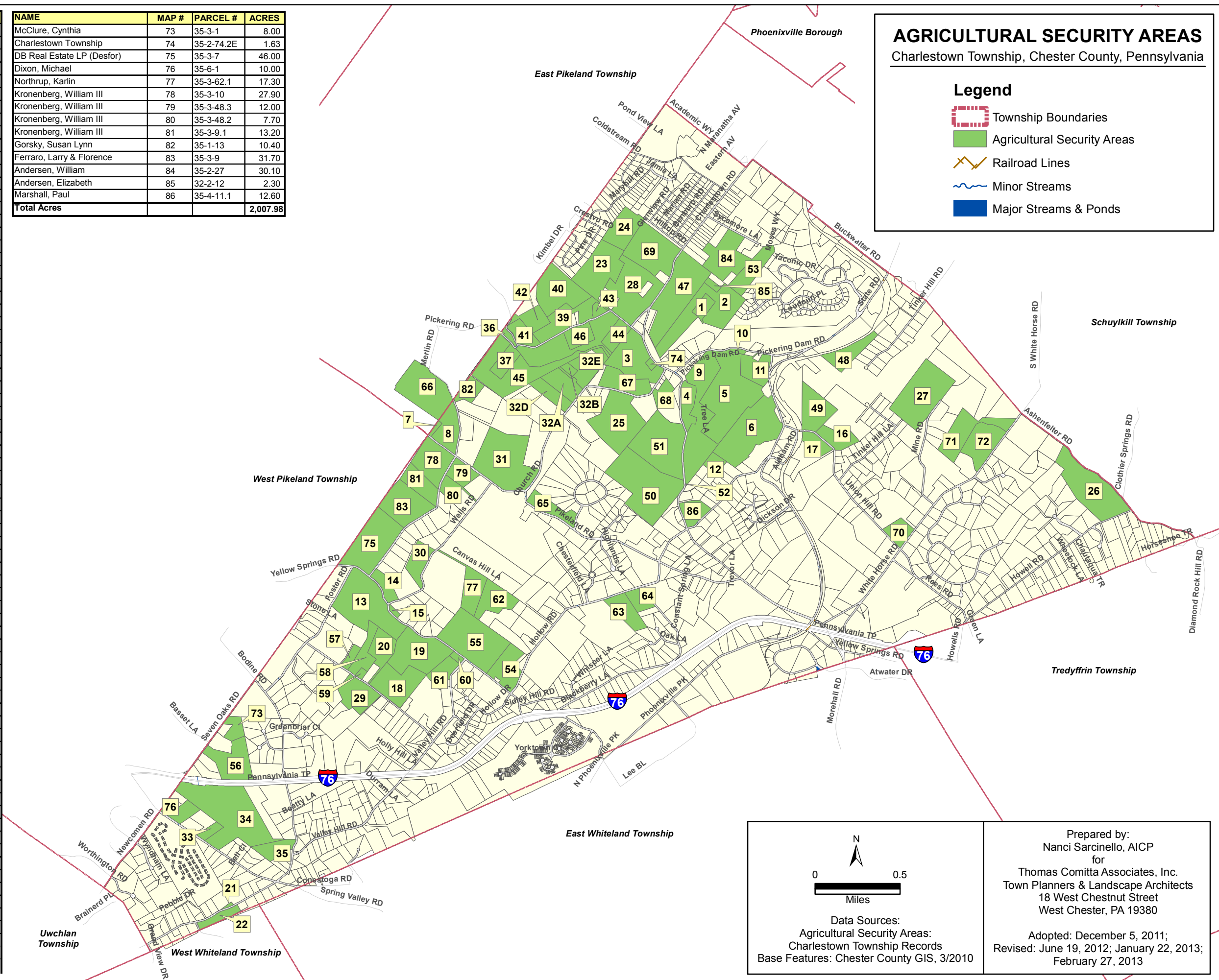

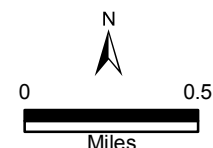


AGRICULTURAL SECURITY AREAS
