PERMIT FEE SCHEDULE FOR 2023

SUBDIVISION AND LAND DEVELOPMENT ORDINANCE FEES

Every applicant, at the time of filing an application for approval of a sketch, preliminary or final subdivision and/or land development plan or tentative or final planned residential development shall pay to the Township a basic filing fee in accordance with this fee schedule and escrow deposits for reasonable and necessary charges by the Township's professional consultants to review said applications.

The basic filing fees referred to above shall be non-refundable. The escrow deposit for the review referred to above herein shall be used to pay for engineering reviews, unusual administrative costs, consultant (including but not limited to legal reviews) agreements and performance guarantees and other miscellaneous costs of application review, but does not include a deposit for site inspections or other monitoring during development. The amounts of such review fees shall be in accordance with the ordinary and customary charges by the engineer and consultants for similar service in the community but the amounts for such review will in no event exceed the rate or cost charged by the Township’s consultants to the Township. When the amount of the initial escrow deposit falls below the appropriate minimum amount indicated above, the applicant shall be notified by the Township Secretary to file sufficient additional monies to bring the balance of the escrow account up to the amount initially deposited. Upon final approval of an application whatever unneeded funds remain in the escrow account, upon request shall be returned to the applicant.

All filing fees are non-refundable.

BUILDING PERMIT FEES

All permit fees are non-refundable. Each permit issued under the PA Uniform Construction Code is subject to an additional \$4.50 State Training Fee (as required by Act 157 of 2006).

PLAN REVIEW: Plan review fees are due at the time of application. The fees are credited toward the final permit fees. Plan review fees are forfeited if the applicant terminated the permit review process.

<p>Commercial, Industrial, Institutional (Non-Residential)</p>	<p>The Plan Review fee is based on the estimated construction value in accordance with the Square Foot Construction Costs Table (gross area X Square Foot Construction Costs) published by the International Code Council (ICC). The values below are used with the current Building Valuation Data which is updated every six months, or February and August, of each year. If the permit process is terminated by the applicant, applicant forfeits all review fees remitted.</p> <p>For buildings with an estimated construction value up to \$3,000,000, the Plan Review fee is 0.0008 of the estimated value (\$500.00 minimum). For buildings with an estimated value over \$3,000,000 up to \$6,000,000, the fee is \$2,400.00 plus 0.0005 of the estimated value over \$3,000,000. For buildings over \$6,000,000, the fee is \$3,900.00 plus 0.00035 of the valuation over \$6,000,000.</p> <p>The Plan Review Fee for Accessibility, Energy, Mechanical, Plumbing and Electrical Reviews are computed at 20% of the Building Plan Review fee for each discipline (\$250.00 minimum). The Sprinkler review is based on the number of Sprinkler heads: 1-100, \$275.00; 100-200, \$325; 201-300, \$350; 301-400, \$375; 401-500, \$425; over 500, \$500.00 plus \$0.33 per sprinkler over 500. For hydraulically designed systems, multiply the fee by 2.</p>

UNIFORM CONSTRUCTION CODE BOARD OF APPEALS: The UCC Board of Appeals hears and rules on appeals from decisions of the building code official, requests for variances and requests for extension of time.

TOWNSHIP ROAD OCCUPANCY FEES

ISSUANCE FEES: These fees are applied to the administrative costs incurred in reviewing the Application and plan(s) and issuing and processing the permit, including the preliminary review of the site location identified in the application, whether or not a permit is issued and processed.

GENERAL PERMIT INSPECTION FEES: These fees are applied to the costs incurred in the preliminary review of the location covered by the permit and/or spot inspection of the permitted work, and/or subsequent inspection after the permitted work has been completed to ensure compliance with PennDOT specifications and permit provisions.

EXEMPTIONS

Permit issuance fees and general permit inspection fees are not payable by any of the following:

1. The Commonwealth
2. Political subdivisions of the Commonwealth, except when placing a facility longitudinally within more than 100 total linear feet of pavement. In that case, the application and inspection fees for pavement openings will be charged.
3. Governmental authorities organized under the laws of the Commonwealth.
4. The Federal Government
5. Charitable organizations that are compliant with Act No. 337, approved August 8, 1963, P.L. 628, as amended (churches, hospitals, schools, charitable institutions, veterans' organizations, non-profit organizations).

6. Utility facility owners for:
 - a. The installation of streetlights at the request of PennDOT or the political subdivision.
 - b. The replacement or renewal of their facilities prior of a township resurfacing project after notice from the township.
 - c. Facilities moved at the request of PennDOT or the political subdivision.
 - d. The reconstruction or maintenance of their facilities that occupy the right-of-way under private status.

ADDITIONAL INSPECTION FEES

If the Township determines that the permitted work is of sufficient magnitude or importance to warrant assignment of one or more persons to inspect the permitted work on a more than spot inspection basis, the permit will so indicate and the permittee shall be charged for additional salary, overhead and expenses incurred by each assigned inspector and the Township.
